The Capital Region Leadership Council, the decision-making body of the We Prosper Together Collaborative, will, through close, meaningful engagement with the Collaborative, consider recommendations moved forward by the Collaborative, a representation of subregions that advance efforts of the Capital Region and build regional alignment.

Purpose: To move the Capital Region planning forward by hearing recommendations, ensuring they meet the inclusivity and equity focus, and advise on regional strategic planning resulting in a targeted strategy and roadmap for low-carbon economic development that prioritizes the creation of accessible, high-quality jobs in sustainable industries for economic prosperity and resiliency throughout the Capital subregions.

Shared Vision: *To develop an equity-based low-carbon economic plan through an inclusive, transparent, co-owned, and subregional data-informed planning process in the Capital Region. The plan will produce strategies to generate high-quality jobs, clear pathways into new jobs for historically left out populations, and a sustainable and equitable economy in the eight-county region.*

Phase 2 of the Leadership Council Nomination Process is to identify and select membership candidates from remaining vacant seats not appointed during Phase 1, and those representing sectors with specific selection considerations.

Eligible nominees **must** live and/or work in at least one of the Capital Region's subregions, **and** represent one or more of the following:

- **Yuba County/Sutter County (1 seat)**
- **California Native American Tribes (3 seats)**
- **Labor/Worker Support Organizations (2 seats)** - including union, worker centers, worker organizing, and/or worker rights representatives
- **Business (3 Seats)** - Including business representatives, owners and/or employers.

Nominations: Members of the We Prosper Together Collaborative are invited to nominate an individual to serve as a member of the Capital Region Leadership Council (approximately one year) and/or may nominate themselves by completing the included nominations form. Leadership Council members must live and/or work in at least one of the Capital Region's subregions and represent one of the remaining vacant seats noted above. Selection Process: Selection of Capital Regional Leadership Council membership will be determined by the Nomination Review Ad Hoc Committee, through blind review and scoring of qualifying nominations. Selection for representation from California Native American Tribes and Labor/Workforce Development will also include reviewers representing those respective bodies. Selected nominees will be notified by **March 15, 2024**.
